RECOMMENDATION ON B-LOGIC

I am the senior director of the law firm Miltons Matsemela Inc. We operate through a network of seven branches in the Western Cape and one in Johannesburg.

During the early part of 2012 we appointed B-Logic to manage all our IT systems including inter-office communication and telecommunication. Up until then we had a service provider who looked after IT but no-one to co-ordinate all electronic aspects of our business.

We also did away with the unstable ADSL Telkom product and are now serviced by high speed stable fibre or wireless inter office communication and as a consequence thereof enjoy the cost savings of VOIP.

The biggest advantage of having appointed B-Logic (by far) is the "one stop shopping". Although B-Logic introduces the required service providers they do not leave the scene and I do not need to deal with these service providers. B-Logic does it all as part and parcel of our monthly service payment to them.
